

# FAEIS Placement Definitions

## Data

**QUANTITY:** sum of headcount reported for the following attributes.

**YEAR:** Year of survey data. Placement data is surveyed under the same year as the associated degree award: the ending year of the prior academic year's placement.

## Institution Details

**LAND\_GRANT\_FLAG:** (0 - no, 1 - yes) The institution was established by the Morrill Acts.

**TYPE:** The specific type of land grant, also differentiating the public non-land grants (NLG) from private non-land grants (PVT).

**STATE:** Primary state of the institution.

**FICE:** The legacy Federal Interagency Committee on Education code.

**INSTCODE:** The Department of Education's Integrated Postsecondary Education Data System (IPEDS) institution code.

**INSTITUTION\_NAME:** Full text name of institution.

**WITHIN\_COLLEGE\_OF\_AG:** (0 - no, 1 - yes) This headcount is within a college identifying as entirely or partially a college of agriculture.

**WITHIN\_COLLEGE\_OF\_NR:** (0 - no, 1 - yes) This headcount is within a college identifying as entirely or partially a college of natural resources.

**WITHIN\_COLLEGE\_OF\_FCS:** (0 - no, 1 - yes) This headcount is within a college identifying as entirely or partially a college of food and consumer science.

**UNIT\_NAME:** The full text name of the immediate lowest level unit reporting the headcount. This may be a college, school, department or other unit of organizational structure reporting degree seeking programs. Frequently, all programs of child units are reported by the top-level college.

**NAUFRP\_FLAG:** (0 - no, 1 – yes) This institution is a member of the National Association of University Forest Resource Programs (NAUFRP).

**APLU\_FLAG:** (0 - no, 1 – yes) This institution is a member of the Association of Public and Land-grant Universities (APLU).

**NARRU\_FLAG:** (0 - no, 1 – yes) This institution is a member of the Non-land-grant Agriculture and Renewable Resources Universities (NARRU).

**CAFCS\_FLAG:** (0 - no, 1 – yes) This institution is a member of the Council of Administrators of Family and Consumer Sciences (CAFCS).

**SAF\_FLAG:** (0 - no, 1 – yes) This institution is a member of the Society of American Foresters (SAF).

**AAVMC\_FLAG:** (0 - no, 1 – yes) This institution is a member of the Association of American Veterinary Medical Colleges (AAVMC).

**HSI\_FLAG:** (0 - no, 1 – yes) This institution is federally listed as eligible for Hispanic Serving Institution (HSI) status.

**HBCU\_FLAG:** (0 - no, 1 – yes) This institution is classified as a Historically Black College and University (HBCU).

## Program Classification Details

**UNIVERSITY\_LEVEL:** Summary indicator showing the headcount is undergraduate or graduate.

**DEGREE\_LEVEL:** Indicator showing the exact degree level.

## Demographic details

**PLACEMENT\_SECTOR:** Sector of placement. These are broad placement categories identifying the type of work the individual will be doing.

**PLACEMENT\_AREA:** Area of placement. These are a subset of Bureau of Labor Statistics occupation groups which describe the type of work being done by the graduate. This is an optional reporting level which augments PLACEMENT\_SECTOR.
